#### **HOW WILL LOTS FOR SOLDIERS SELECT AN APPLICANT FOR A NEW HOME?**

An application must be completed by a current or honorably discharged military person who wishes to be considered for a new home. All applications will be reviewed by an independent selection committee that will determine eligibility based on the following criteria:

- **Need:** the housing based on the need for suitable shelter (but only as compared to other applicants.)
- **Ability to pay:** the applicant's income and ability to pay housing and other monthly expenses.
- **Willingness to participate:** the applicant's ability and willingness to become partners with Lots for Soldiers in the construction on a new home.

The selection committee will consider the applicant's income, debts and other financial obligations. If selected for a home, the applicant must secure financing prior to the commencement of construction. The payment plan will be mutually arranged by the lender, the applicant and Lots for Soldiers in advance of construction.

**Lots for Soldiers** will donate the residential lot and then the cost of building this home will be kept as low as possible due to the volunteer labor and discounted or donated supplies and services used to build the home. Applicants are asked to invest time and labor into the construction of their home; a good guideline is the investment of 500 hours.
